This privacy policy will explain how Jungheinrich (hereinafter referred to as "we") will use and protect your personal data and privacy when you use Marketo. Please read and understand it carefully before using our products or services.

## 一、我们收集个人信息的方式 How we collect personal data

您可通过永恒力的新闻通讯及电子邮件从我司接收消息和最新报价。如您已在"新闻通讯(Newsletter)"栏目项下填写您的电邮地址,点击"订阅"按钮并通过我司向您填写的电邮地址发送的链接再次确认您的订阅(双重确认),我司将会受理您的订阅,并使用您的电邮地址定期向您发送新闻通讯。

You can receive news and current offers from Jungheinrich via our newsletter and emails. If you have entered your e-mail address under the heading "Newsletter", clicked on the "Subscribe" button and confirmed your subscription to us again via the link sent to the e-mail address you entered (double opt-in), we will process and use your e-mail address to send you the requested newsletter on a regular basis.

在您对新闻通讯进行订阅的范围之内,为向您发送相关信息,我司将使用 Marketo EMEA Limited(地址: 4-6 Riverwalk Drive, Citywest Business Campus, Cooldown Commons, Dublin 24, Ireland)提供的名为"Marketo Engage"(以下称"Marketo")的营销自动化软件。为此,我司根据《通用数据保护条例》(DS-GVO)第 28 条的规定,与该软件的提供商签订了一项合同。在该合同中,该软件提供商承诺仅按照我司的指示处理用户数据,并遵守与数据保护相关的规定。在《DS-GVO》的范围之内向第三方转送数据的情况除外。我们在此承诺,我司在使用该软件过程中将遵守中国现行有效的与个人信息保护相关的法律、法规等规定,履行个人信息保护义务。

Within the scope of the registration for the newsletter as well as for sending information to you, we use the marketing automation software Marketo Engage of Marketo EMEA Limited (hereinafter referred to as "Marketo"), 4-6 Riverwalk Drive, Citywest Business Campus, Cooldown Commons, Dublin 24, Ireland. For this purpose, we have concluded a contract with the provider in accordance with Art. 28 DS-GVO, in which the provider undertakes to process

the user data only in accordance with our instructions and to comply with the data protection provisions. A forwarding of the data to third parties in the sense of the DS-GVO is excluded. We hereby give our undertaking that when using this software, we will comply with China's current effective laws, regulations and other provisions related to personal data protection and fulfill our personal data protection obligations.

## 二、我们收集哪些个人信息 What personal data we collect

在 Marketo 软件的帮助下,我司收集与我司网站使用情况及通讯措施有关的数据,以便相应优化我司产品和实施电子邮件营销、个性化和销售活动。在此过程中,数据处理部分是自动化的,且其目的是对用户的特定方面(用户画像/客户群体细分)进行评估。

With the help of Marketo, we collect data about the use of our website and communication measures in order to optimize our offer accordingly and to conduct email marketing, personalization and sales activities. In doing so, the processing is partly automated with the aim of evaluating certain personal aspects (profiling/customer segmentation).

The following master data is affected: Customer and prospect data (e.g., name, company, address), business-related data (e.g., role, profession), marketing consents (e.g., newsletter consent), Website usage data (e.g. length of visit, click behavior, number of pages viewed, documents downloaded), data from marketing campaigns (e.g., website visits, webinar registrations), contract and delivery information (e.g., order or delivery date) and customer satisfaction data (e.g. from surveys).

此外,我们存储与您使用的浏览器、操作系统设置及您访问我司网站使用的网络连接等相关的信息。通过向您发送新闻通讯,我司将会收到"收件和已读回执"及与您在我司发送的新闻通讯内点击的链接相关的信息。我司还会存储您在我司网站及我司APP内访问的区域相关的数据。

In addition, we store information about the browser you use and the settings made in your operating system as well as information about your Internet connection with which you have accessed our website. Via the newsletter sent to you, we receive, among other things, receipt

and read confirmations as well as information about the links you have clicked on in our newsletter. We also store which areas you have visited within our website and in our apps.

### 三、我们如何使用您的个人信息 How we process your personal data

在这些数据的帮助下,我司将实施定期的及视具体场景而定的(如在用户下载白皮书后,即"场景相关事件")电子邮件营销活动,如发送新闻通讯,邀请参加(数字)活动,"潜在客户培育电子邮件"及自动发送邮件。

With the help of this data, we implement our regular as well as occasion-related email marketing activities such as newsletters, invitations to (digital) events, nurturing emails and automated mailings for example after a whitepaper download (occasion-related event).

此外,您的数据还可用于我司网站内容的个性化显示。例如,根据您的使用行为,我们会显示相关的网络活动、推荐或优惠,前提是您已在我们的许可管理系统中同意用于营销目的。我们还可以使用定位数据通过广告合作伙伴向您展示其他线上优惠的定向广告。

We can also use targeting data to show you targeted adverts on other online offers via advertising partners.

To find out which of our company's services are of particular interest to you, we create a contact profile. The contact profile is completed using analytical and statistical methods based on heuristic algorithms. This approach is also referred to as contact scoring and segmentation. For more information, please refer to the Cookies and Tracking section. The data is also used for statistical purposes.

四、我们如何委托处理、转让、公开披露您的个人信息 How we entrust the third-party to process, transfer and disclose your personal data

(一)如我们委托合作方处理您的个人信息,我们将会与合作方约定委托处理的目的、期限、处理方式、个人信息的种类、保护措施以及双方的权利和义务等,并对合作方的个人信息处理活动进行监督。我们目前委托处理个人信息的合作方为 Marketo 的软件供应商 Marketo EMEA Limited。

If we entrust our partner to process your personal data, we will agree with our partner on the purpose, period, processing methods, types of personal data, protection measures, rights and obligations of both parties, etc., and we will also supervise personal data processing activities of our partner. The partner we currently entrust to process personal data is Marketo EMEA Limited, Marketo's software supplier.

(二) 我们不会将您的个人信息转让给任何公司、组织和个人, 但以下情形除外:

We will not transfer your personal data to any company, organization or individual, except in the following circumstances:

Under the following circumstances, obtaining your prior authorization and consent for our partner to use or us to transfer or publicly disclose your personal data is not required:

- 1. where it is necessary for the conclusion or performance of a contract between us;
- 2. where it is necessary for the performance of statutory duties or statutory obligations;
- 3. where it is necessary for the response to a public health emergency or for the protection of the life, health and property safety of a natural person in an emergency;

- 4. where such acts as news reporting and supervision by public opinions are carried out for the public interest, and the handling of personal data is within a reasonable scope;
- 5. where it is necessary to handle the personal data disclosed by the individual concerned or other personal data that has been legally disclosed within a reasonable scope in accordance with Personal data Protection Law of the PRC;
- 6. Other circumstances stipulated by laws and administrative regulations.

## 五、Cookies 与用户行为追踪 Cookies and tracking

Marketo collects your IP address and uses cookies to track and analyze site usage in order to provide information specifically tailored to the user's interests. For more information about cookies, please see "Cookies - General Information". The information generated by the cookies is transferred to a Marketo server (located within the EU/EEA) and stored there. You can prevent the storage of cookies by setting your browser accordingly. Browser settings made by you may, however, result in you possibly not being able to use all functions of our online offer.

#### 六、保护您的隐私 To protect your privacy

For instance, we use encryption technology to ensure data confidentiality, protection mechanisms to prevent attacks, and access control mechanisms to allow only authorized access to your personal data. We also conduct data security and privacy protection training for employees to improve their awareness of personal data protection. We are not legally responsible for any unauthorized access, disclosure, use, damage or loss of your personal data not caused by us. We are committed to protecting your personal data, but please note that no security measures are foolproof.

We will take all reasonably practicable measures to ensure that no irrelevant personal data is collected. We will only retain your personal data for the minimum period necessary to fulfill the purposes described in this Privacy Policy, unless a longer retention period is required or permitted by law.

If our physical, technical, or management protection facilities are damaged, resulting in unauthorized access, public disclosure, tampering, or destruction of data, resulting in damage to your legitimate rights and interests, we will bear corresponding legal liability.

If a personal data security incident unfortunately occurs, we will promptly inform you the following matters in accordance with laws and regulations:

the basic situation and possible impact of the security incident, the handling measures we have taken or will take, and suggestions for you to prevent and reduce risks on your own, remedial measures for you, etc. We will promptly notify you of the incident-related information through emails, letters, phone calls, push notifications, etc. If it is difficult to notify the personal data subjects one by one, we will issue announcements in a reasonable and effective manner. Meanwhile, we will also proactively report the handling of personal data security incidents in accordance with the requirements of regulatory authorities.

You can make a request to delete personal data under the following circumstances:

- 1. If our processing of personal data violates laws and regulations;
- 2. If we collect and use your personal data without your consent;
- 3. If our processing of personal data violates our agreement with you;
- 4. If you no longer use our products or services, or you cancel your subscription;

5. If we no longer provide products or services to you.

We may reject requests that are unreasonably repetitive, require excessive technical means (for example,

require the development of new systems or fundamentally change existing practices), pose risks to the legitimate rights and interests of others or are highly impractical.

After this Privacy Policy is updated, we will notify you in an obvious position on Jungheinrich's official website, by messages or in other ways to remind you so that you can be keep informed of the latest version of this Privacy Policy. We will also keep previous versions of this Privacy Policy on file for your review.

# 九、我们如何处理不满十四周岁未成年人的个人信息 How we deal with personal data of minors under the age of fourteen

不满十四周岁的未成年人使用我们的服务前应取得监护人的同意。如您为不满十四周岁的未成年人,在使用我们的服务前,应在监护人的指导下共同阅读本隐私政策且应在监护人明确同意和指导下使用我们的服务并提交个人信息。我们根据中国相关法律法规的规定保护不满十四周岁未成年人的个人信息,只会在法律法规允许、监护人明确同意或保护您的权益所必要的情况下收集、使用或公开披露不满十四周岁未成年人的个人信息。
